

The Second Vatican Council has called us to envision the

Church as the people of God. As a community of believers we are responsible for our brothers and sisters, their salvation, their journey of faith, their physical well-being. Many of the documents of Vatican II and volumes of work since the mid-1960s give us advice, guidelines, and encouragement to take care of one another: the poor, the elderly, the unborn, the broken, the infirm.

Because Vatican II is part of our recent history--indeed many of us were already born--this may strike us as a new and revolutionary idea. But today's readings show us the agelessness of the issue of social justice. Eight hundred years before Christ was born, Amos warned the wealthy not to cheat the poor. In Paul's first letter to Timothy, he encourages all prayers to be for all people; and finally, the

ST. IGNATIUS FISCAL CORNER

In this week's bulletin you will find our FY 2016 Annual Parish Financial Report. This report has been submitted to the Archdiocese and is currently being reviewed. The report shows our cash position from last year, which identifies excess operating expense over income of \$117,267. This was a direct result of our decrease in Sunday offerings, which fell from \$971,406 in FY 2015 to \$862,756 in FY 2016. This shortfall was covered with cash reserves from the prior fiscal year, as well as a drawdown from our savings. Two other important figures from the report are the parish debt and the subsidy paid to the school. In FY 2016, the parish subsidy to our school was \$356,608 or 27% of their operating expenses. This was down from a subsidy amount of \$380,781 in FY 2015. Our parish debt as of 6/30/16 was \$1,811,126. This figures does not include the proceeds from the land sale of \$617,886, when applied would bring our current debt down to \$1,193,240. A thrift shop was constructed .Shelves were put in, a confessional was converted into a dressing room, rooms were repainted and cosmetic improvements were made when needed.
